Executive Summary

This document provides feedback to all stakeholders who participated in the consultation exercise undertaken by NATS for the Proposal for Midlands Region Transition Altitude Harmonisation and Redefinition of the Daventry CTA

The stakeholder consultation was of 12 weeks' duration commencing on 28th May 2010 and closed on 20th August 2010. The stakeholder consultation document was distributed and/or made available to a total of 117 representative organisations. These are listed on pages 20 & 21 of the Midlands Region consultation document.




Figure 1. All stakeholders' responses pie chart

Figure 1 below shows the proportions of responses from all those stakeholders that responded to the consultation.


1. Introduction

This document provides feedback to representative organisations who participated in this consultation exercise. This document has been sent to all stakeholder organisations which participated in the consultation, and is posted on www.nats.co.uk

2. Suggestions for design modifications

NATS has listened to the feedback received from all of the stakeholders and other responders during the course of the consultation. There was evident support to the proposal to harmonise the Transition Altitude in the Midlands region to 6000ft, and to redefine the Daventry CTA. As there were no objections to the original proposal, NATS will not be proposing any modifications to this. DAP have recommended a very minor change to the north-east corner of the proposed DTY CTA. The proposed area is shown in the illustration below.

NATS will now raise and formally deliver an Airspace Change Proposal to the Directorate of Airspace Policy, CAA no later than 31st August 2010.

It is estimated by NATS that a DAP decision on the Airspace Change Proposal can be anticipated around 13th December 2010.

3. Key issues and themes identified

There was evident support from a wide range of stakeholders to the proposal to harmonise the Transition Altitude in the Midlands region to 6000ft, and to redefine the Daventry CTA. As there were no objections to the original proposal, NATS will not be proposing any modifications to this.



4. Summary of responses¹




Figure 2 Stakeholder group responses
